PART I: ASCENSION TO LIBERATE

TOPIC I –TIMELINE

TOPIC II- IDENTITY CRISIS

When competitive enterprise is added to capital growth, it decreases the chances for fair competition amongst nation states and also inter groups workforce.

The migration of talent to other provinces and territory interrupts the flowdarity of nation building, as this practice shows history of transformational dividing, one of the human civilization trait to improve cultural colonization and increase their chance of protecting their lineage.

Conquests divide their lineage and pronounce its actions as a necessary roadmap building, decreases only for the good of state frontierism.

The conquering of states economies to sustain other economies continues to be a long practice, aided by globalization but its effects increases the mobilized population, to be delineated of their historical lineage and away from its original practices.

The self caught on a dilemma persona, to be a one factor identifier to an identity not prescribed by their culture. This anger and resentment of adopting an identity and to cope with its character, bitters a mobilized population and creates internal aggression only manifested into a form of anarchism.

These anarchist aggressions found in mobilized population, adopting new cultural practices within a wealthy capitalist system or a weaker economic slavery states; cannot heal a nation from a history of conquest.

At times, these unearthed populist agenda springs out without warnings, thinking that their beliefs system is of the past and should not be part of the new modern era.

As the new modernized blueprint have addressed the old industrial period of modernization and all are considered equal; so is their contribution to state rebuilding more important than its destruction.

The identity crisis plagues further; pressuring the two identifiers of the state: its statehood and state authority; as both signifies if a country can survive within any period of the globalization eras, as many distracters inhibits chaos rather than order in their attempt to frustrate the stressors in the economy.

TOPIC III- ATTRITION DILEMMA

Infused within colonized states which have emerged from conquest during time resurrection, shows much difficulty in coping in a new identity, a nation can identify with amongst the other nation states.

Its manifestation of power cannot be unearthed to its fullest potential if many of the identifiers within the states have not reconcile their terms of new conditionality.

Rhetoric diplomacy and falsehood attributes in disguise mimics a future scope for all citizens to adore, to hope for and to all generational growth to sprout new offspring's of ideas, creativity and originality.

Sprung out instead are offspring of contentment, bitterness, resentment and hopelessness, that their divisional slave

economy cannot improve their system of desires but instead creates a bargaining tool of negotiating what is necessary for their continual survival.

Divisional rulement; its honor, its code and its regiment's functions as a shadow state of affairs, imaging the state resources to whatever the shadow casts itself onto.

Survivalism then steps in as a continual resort to dispose of all actions from civil authority that the slave economy, can function on a socialist banner and the privileges of elitism order is disastrous and evil to all inter groups.

Civility groups forms intra groups, merged by oppressed literatures on chaotic principles. For a supposed hopeless society, wanting an identity similar to other nations states counterparts.

State rulement becomes illusive and counterproductive to a disenfranchised citizenry state, forcing countless battlefields for scarce resources thus depleting their competitive rights to become a useful economic slaved economy.

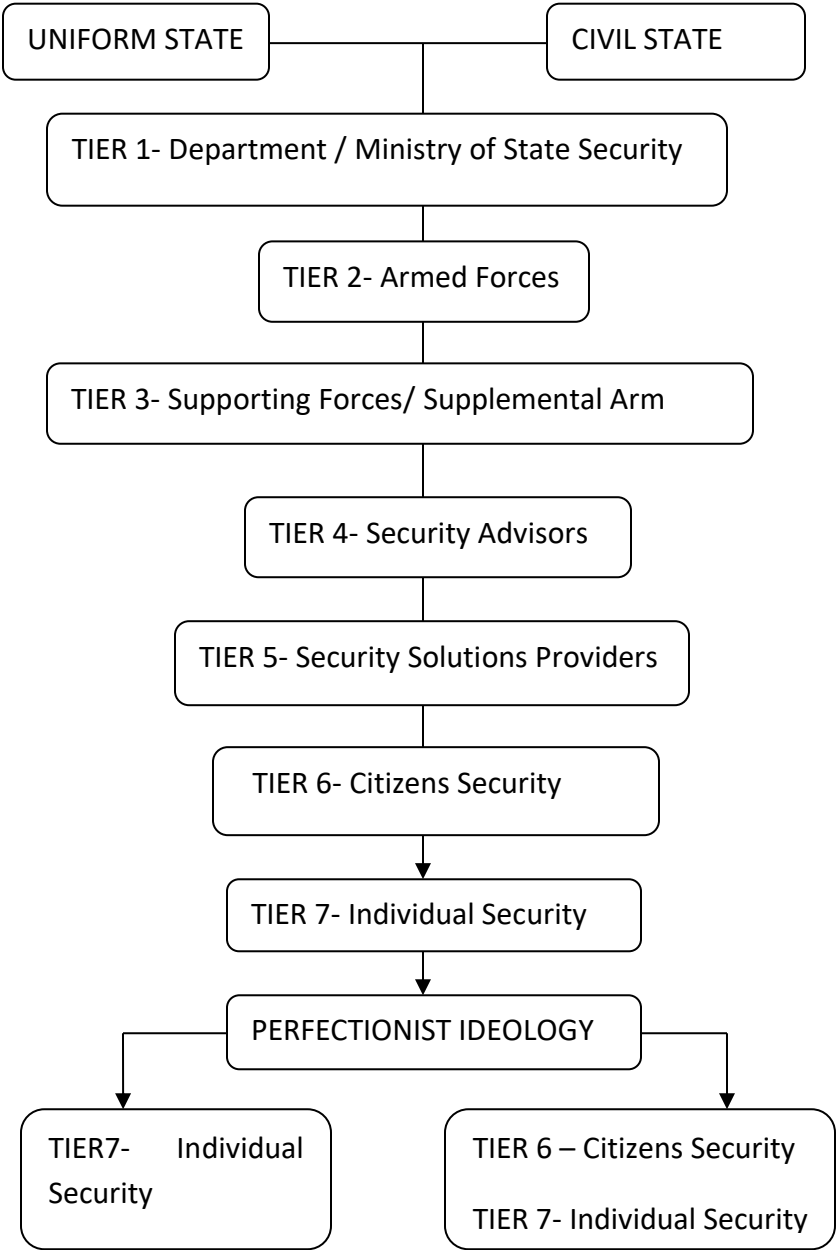

Their security issues can be numerous; as intensification, modernization and its operation depends on the state resources, amid their bargaining position amongst other nation states; to use for other resources to improve, harness or protect its depleted resources.

As internalized history of conquest would delay instant originality and innovation to improve societal indifferences, their position towards the 5th industrial security revolution is evolutive slow.

When identifying new modernization frontier strategy in regard to national security, the bonding model is used as an indicator model in determining their strength over their citizenry chaotic-cy intentions.

The security researcher can use this bonding ideology chart as a basic model to investigate the current security status of a nation state.

Its improvements rest on the security researcher adaptation to utilize the 5th industrial security revolution framework over the bonding model.

A qualitative analysis on the Protectionist Ideology

TIER 1- Department or Ministry of State Security-

I. is the department of security solely controlled by the civil state authority? And if so, how much autonomy is given to the department of security in developing strategic security solutions without the civil authority?

II. does capital expenditures rests solely on the state or can funding be acquired by other means?

III. is the department an independent body created to be a separate entity from political reigns or party politics?

IV. are the appointees of the department great contributors to changes and thought leaders in improving the national security sector?

V. can the department be seen as a researched organization, possessing continual researched data on current issues, plaguing the internal and external security framework of the nation state?

TIER 2- Armed Forces-

I. does the organizational structure of all armed forces contribute to the division of civil and uniform authority and in its functionality?

II. do any of the armed forces divisions discriminate against any sector or groups of the society?

III. do any of the armed forces recruit all its cadres of officers based on meritocracy, intellectuality, nationality or loyalty to the country's defense.

IV. does the armed forces have a history of attempted coup-e-tat, kill squads, shadow groups or hired contractors for the exchange of wealth and political favors?

V. does the armed forces governance structure falls under the remit of a civil authority or a group of segmented civil statutes?

VI. do the armed forces have a history of involvements in national politics or national political parties?

VII. is the civil authority capable in handling all affairs of governance on the entire armed forces of a nation?

VIII. does the armed forces authority have a continual history of selecting its personnel from a particular societal class structure?

TIER 3- Supporting or Supplemental Armed Forces-

I. is there a partnership between state and statehood in relation to filing of ranks of the supporting arms?

II. does fiscal economic policies and lack of resources, delay the recruitment of supporting armed forces in the local state entity?

III. does designated appointees, to govern supporting arms, overshadowed by legal statutes and apparatus to inhibit a controlled structure of the use, implementing or forming the powers of supporting in threat situations?

IV. do international bodies support most of the local cadre of officers through international support networks and treaties?

V. does the societal cultural history of the nation encourages other armed sects, to be part of a nation defense in times of external aggression?

TIER 4- Security Advisors-

I. does it have a national advisory body coordinated to be the central authority in authorizing advisors to practice consultancy?

II. if not, does the practice of security advisors govern under a authority to license, audit, recruit, transcend advice or formulate national defense frameworks?

III. if not, do individuals security advisors independent away from a national advisory board or authority, possess consultant or advisory qualifications, to meet the demand of providing security advice to corporate, government or other international agencies, operating locally?

IV. does it have existing and current legislative framework which address the security industry standards and best industrial practices?

TIER 5- Security Solutions Providers-

I. does the nation state under study possess innovative and original technological advanced solutions which are domestically made?

II. does the nation state under study rely mostly on other security solution providers not domestic to the nation? If so, how much reliance are there to protect against information war, espionage and third party risk?

III. is the nation state under study a technocratic state authority?

IV. does it have existing and current legislative framework designed to protect the nation state from security solution providers domestically and globally?

TIER 6- Citizens Security-

I. does it have an existing and current national public safety and security framework; govern under many public safety and security laws, policies, guidelines, models and tools, enforcement and divisional authorities?

II. does the department of security or ministry act as an intermediate entity, in all security matters within all intergovernmental bodies and act as a protectionist for all state resources, under any public safety and security framework model?

III. does the nation state posses enough resources to monitor all citizens actions, through the effort of public safety and security laws?

IV. Does the nation state under study have any future interest in introducing a security state, as a citizen security model to improve investor relations, societal productivity and decrease high intensive criminality?

V. does the nation state have a history of sectarian violence, political violence or intergroup territorial disputes; waged by armed rebels entities, armed loyalist factions or ethnic sects formed within the local citizens community?

VI. does citizens in the nation state collectively posses enough arms to create rebellionism and continued conflict against both civil and uniform authority?

TIER 7- Individual Security-

I. is societal survivability antagonistic to state and statehood?

II. is there a sense of apprehensiveness from the state against rebellionism form citizens?

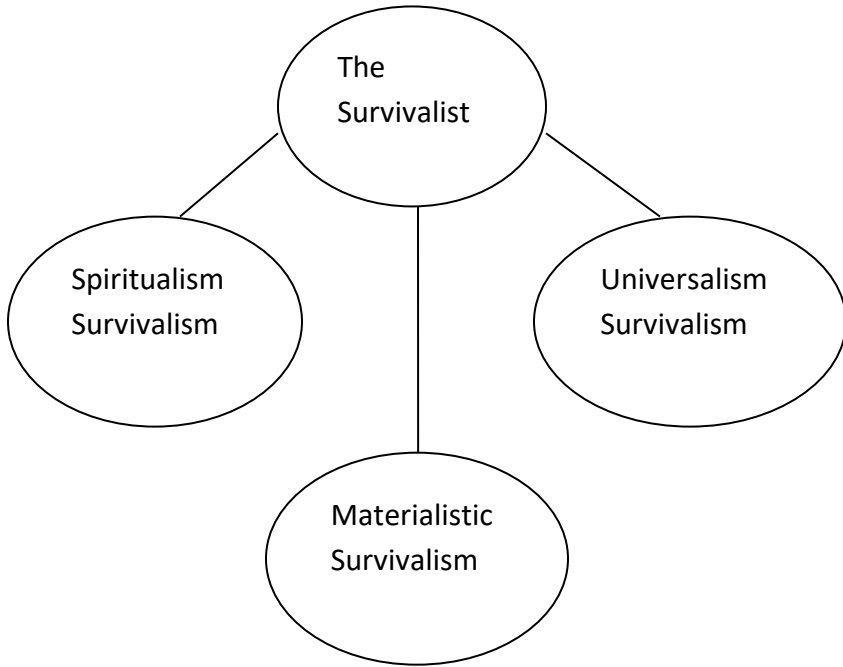
III. is there a divided citizenry state, in relation to the protectionist state and the non conformist citizens fight for totalitarianism?

IV. is there a measurable rate of comfortable comparison between criminality and conformity with the state under study?

V. Do citizens' survivability increased within a sectoralist intra-grouping society?

VI. do citizens prefer state security ideals or the anarchists security structure as a means of survivability?

TOPIC V- UNIVERSALISM- SURVIVALISM



Survivalism can be seen as a broad term, when other territorial entities are added, to the equation of citizens' safety and security and civil or uniform authorities' plans to create a unified state.

All forms of survivalism possess their unique existence amongst the survivalist epoch. As each form they occupy for sustenance, aids the survivalist further into developing all parts into one whole.
