Seeing this, it is solely on improving investor relations in creating new emerging markets within the commonwealth, which can broaden the supply curve and lessen the dependency curve from other member states.



FOUR TYPES OF PRIVATE SECURITY OPERATIONS NEEDED IN ALL COMMONWEALTH ECONOMIC STATES

SECURITY OPERATIONS TYPE 1THE UNDERDOG OPERATIONS

THE MACQ TECHNIQUE FOR THE FIELD OPERATOR

The underground operational techniques are designed to entrust to the field operator, skillets necessary to survive their already security operations, in states which are hostile and require an adoptive skills which are more mathematical in designed.

The Mathematical Algorithmic Close Quadrant Technique (MACQ) is one such technique examined in this type of operation.

The MACQ technique encourages mathematic technical behaviors within all close quadrant space occupied by an operator during their operation.

Occupied space found within mobility or immobility for a considerable length of time is considered to be mathematical in design.

Operative words here is *mathematical-algorithmic* meaning their basis metrics and knowledge of math and reformatting its results into controlling space occupied, formulate it as a rhythmic every session technique to allow approaches to be more methodical.

There is no single multifactor use of best metrics approach as familiarity with basis math used locally can enhance the additional survival tactics, a corporate institution may or may not instill in training.

As an assurance its application of applying accuracy in the area of control, ensuring knowledge on every aspect of the space under direct protection.

Be familiar with the architectural measurements of the design of the space occupied direct to protection by having access to its blueprint; if not available there are security standards for designing building for protection, get access to such information and test its applicability with the best type structural design at the existing premise.

Having knowledge on all structural space and its limitation; as occupied space can be compromise and to what extent shall the operator enforce protection measures to control their own quadrant space.

The operator force must be greater than the perimeter force protection at every quadrant space within their space to protect, no matter its fortification mantle. The MACQ technique quite simple indeed is just a reflection of space protected must not exceed space occupied by the operator.

The operator must know their strength application and their weakness too and possess the inside knowledge of their territory to enter into a space where their weakness can be enhanced where threats are imminent.

For not all occupied space are designed architecturally for the purpose of security in mind. Its afterthought application of including contract operator, to be the protector of its corporate assets may not possess the space for the operator to possess a controlled space quadrant, to survive any threats which target the protector more so than the structure.

Incumbent for the operator to not be a target but to apply the MACQ technique, along with additional self defense techniques and tools necessary for the operations of a specific duty.

The purpose of a underdog is to be ruthless where danger are incumbent, to appreciate the field of security and to prevent being a statistic, to perform the duty professionally and with both foresight and hindsight in mind, in relation to counterrepetitive actions liable for the performation of duties.


The MACQ technique becomes the new metrics for operation by the operator once knowledge of a situation assessment is conducted.

Situational assessments are using metrics to address how the operator presence can incur or defer the level of threats within the operation of their duty.

Many formats within the industrial security known and used are incremental in understanding the vulnerabilities of a territory about to be occupied.

Application of the assessment encourages a situational awareness presence of its territory and further evolves into a situational awareness behavior, necessary for the operator to adopt comfortably within their occupied territory.

Hence the MACQ is one such situational awareness behavior an operator can use as a tool to enhance their operation to be more mathematical in understanding their territory and its application to their own continual survival at the location.



A design showing how the operator tests the perimeter defense capability by creating suggestive threats scenarios, once being occupied at different space area on the perimeter being protected.

It examines their mathematical approach within their space and if the presence of threats arises, how the operator can have access to structural defense mechanism or be able to control their quadrant at the point of attack.

MACQ technical

1. Know your space occupied distance by establishing your own distance of threat one can deter and also to protect with their life.

- 2. Know your territory occupied and be alert to every type of localize changes to the territory whilst on duty and on entry towards a territory.
- 3. Know your strength capabilities and what the necessary weaknesses which need to be enhanced are.
- 4. Client to client relations is not client to operator relations. For the former, is a business solutions agreement and the latter are property protection agreement.

Having knowledge of this implies that the operator propose is to protect assets regardless of the position the operator undertakes so as such no harm is done to self or property.

- 5. Know your limitations; observe all situations to be threatal. Your level of threats must be determined quickly and its approaches to its minimization must be enhanced quickly.
- 6. Security is teamwork; no matter your skills level remember "space occupied is not always space protected."
- 7. The security profession is about personal growth, having knowledge to the latest security information; local and

foreign security related news is essential in determining threats levels at your location being occupied.

As such developing your own situational awareness program for the territory enhances your chances of survivability.

- 8. There exists many security frameworks, technical's and tools which can aid an operator from being inoperable. Having knowledge about them are necessary and you must use them proficiently and professionally with or without the approval of your security commanders.
- 9. Security survival begins with you the field operator!
- 10. Keep all essential documents private and confidential on territories observed and assessed.

SECURITY OPERATION TYPE 2THE SECURITY DOG

OPERATIOANL DESIGN AND MANAGEMENT OF A PARAMILITARY SECURITY GROUP In most commonwealth states security structure depicts a paramilitary structure. Based on their jurisdictional principles and national state laws, their structure are not prohibited but encouraged.

Guided by their institutional policies and legislative frameworks, these entities provide services to the business platform clients.

6. Note that some existing private security operations possess paramilitary security culture but their operations are not; as they are guided by state laws and policies.

Any business mergers where the major stakeholder demands a paramilitary security group to be emanated in the company's business framework, then the culture may be operationalized having done proper communiqués to all legal departments and entities governing its existing on the state.

As both security entities functionality are different, serving different operations and their reliance on economic value bear little allegiance to the time essence of what a business entity sole reliance is on, in relation to interfering with corporate ethical relations, is a financial disaster wanting to be discovered.
